Transit Asset Management Final Rule:

On July 26, 2016, the Federal Transit Administration published the [Transit Asset Management \(TAM\) Final Rule](#). The purpose of the Final Rule is to help achieve and maintain a state of good repair (SGR) for the nation's public transportation assets in an effort to improve safety and increase reliability and performance. The TAM Final Rule groups transit providers into two categories: Tier I agencies and Tier II agencies. Tier I agencies are transit providers that operate rail or have 101 vehicles or more across all fixed route modes or in one non-fixed route mode. Tier II agencies are transit providers that receive 5311 funds, are American Indian Tribes, or have 100 vehicles or fewer across all fixed route modes or in one non-fixed route mode. Tier I agencies must create their own TAM plans while Tier II agencies have the option to participate in a group plan drafted by a sponsoring agency (sponsors are usually a state's Department of Transportation or a Tier I agency).

The Virginia Department of Rail and Public Transportation (DRPT) sponsors the Commonwealth's group TAM plan. [DRPT's initial Group Transit Asset Management Plan](#) was published on October 1, 2018, in accordance with the due date established in the Final Rule. The plan must be updated in its entirety every four years, making the next full plan update due October 1, 2022. Before October 1, 2020, DRPT will issue partial updates, or addenda, should any major changes occur.

Federal Fiscal Year 2020 Addendum Overview:

Three major changes have occurred since the publication of DRPT's group TAM on October 1, 2018 triggering the need for this Federal Fiscal Year 2020 Addendum: the adoption of TAM performance targets for federal fiscal year 2020, the addition of a new transit agency participant, and the implementation of a new capital funding prioritization process at DRPT.

The initial plan published on October 1, 2018 established performance measures and targets for the first two years of the plan. This addendum adopts targets for the federal fiscal year 2020. All targets will remain at the same levels as the 2019 targets which were established in the publication of the initial plan in 2018.

In 2019, Arlington County chose to opt into DRPT's group TAM plan. This addendum documents the inclusion of Arlington County as a group TAM plan participant and incorporates the County's assets into DRPT's group TAM plan asset register.

Virginia's General Assembly enacted legislation in 2018 requiring that DRPT allocate capital assistance funds through a project-based prioritization process. Under DRPT's new statewide public transportation grants program [MERIT](#), the prioritization process used to allocate capital assistance funds determines which projects achieve the policy objective of maintaining a state-of-good repair of existing assets and determines which projects receive funding for new investments. This new process supports the purpose of the TAM Final Rule by prioritizing funding for the replacement of assets that have met or exceeded their estimated service life in an effort to improve the safety, reliability, and performance of public transit in Virginia.
